Yes, this manuscript is important for the local context in India. However, it needs to be revised first. In its current version it includes a lot of repetition and information that is not referenced properly.</p> <p>2. I suggest the change of the title to read: Impacts of Climate Change on Insect Pests and Crop Production: A Review</p> <p>3. The abstract is OK.</p> <p>4. Sections and subsections of the manuscript need to be revised and repetition be removed.</p> <p>5. It is an important effort that need to be revised to bring the best out of it.</p> <p>6. A lot of the manuscript miss a reference. This should be revised and appropriate referencing should be provided for text in the manuscript.</p> <p><u>I suggest that the authors do thefollowing:</u></p> <p>1. Provide scientific names in full when first mentioned.</p> <p>2. Follow the Journal's guidelines for references style, using a single style consistently.</p> <p>3. Revise the sentence in lines 57-59.</p> <p>4. Mention Table 1 in the text; consider writing a paragraph about diversity and referencing the table.</p> <p>5. Revise the numbering that starts abruptly in line 87.</p> <p>6. Reference and rewrite paragraphs from line 87 to 109.</p> <p>7. Clarify or delete the sentence about the effects of elevated temperature on insect pests in line 116 to ensure it fits with the surrounding context.</p> <p>8. Remove repetition and ensure the manuscript's titles are ordered logically.</p> <p>9. Revisit and revise the introductory paragraphs to ensure they flow smoothly from the beginning of the article.</p> <p>10. Consider shortening the article.</p> <p>11. Ensure all information is properly referenced, as this is a</p>
